Lake Committee Report. Meeting held May 1, 2023



Geese

We mistakenly addled eggs on private property and were given a written warning by the State Game Commission. Our permit was reviewed with our Game Warden and steps are in place so that our volunteers know not to venture onto any property other than that owned by WLLA. Hazardous Algae Algae can be hazardous in certain

quantities and conditions. It is important that, if larger amounts of algae are observed, the committee be notified ASAP to test and treat the algae. All testing would be done under an understanding with PLEON.

Beach Testing

Weekly testing is required by the PA Dept. of Health. We have engaged Sekula Labs once again to perform testing at Clubhouse Beach and West Shore Beach starting the week prior to Memorial Day. Should the test show positive for harmful bacteria, we will immediately be notified and that beach will be closed. Every effort to retest ASAP will be made so that beach may reopen. Harmful bacteria is usually the result of animal feces getting into the lake, so please clean up after your pets and do not feed or encourage the geese in any way.

Fish Stocking

We stocked the lake this past month with the following fish:

- 350 LMO Bass
- 100 Shiners for smallmouth bass populations and to increase sunfish angling
- 100 Black Crappies to supplement food for yellow perch. Increased size in the yellow perch creates food for increasing the black bass population

Bobby Jovanovic generously donated funds for 350 additional bass for the lake and our supplier was able to bring those as well.

Catch and Release is strongly recommended for any bass or pickerel caught in our lake.

Creel Survey

We're conducting the 2023 creel survey via a link on Facebook and the Walker Lake webpage. We'll also print out cards for the office and/or security to distribute to anyone interested/unaware. The survey gives us additional information to help decide to stock the lake in the future.

Beavers

One beaver was trapped and removed, but there is additional evidence of a second beaver remaining at another location. Homeowners who suspect that a beaver is on their property should contact the office, who will contact the Lake Committee. While WLLA will have any beavers removed, it is the property owner's responsibility to remove the beaver den. Dens can be re-occupied by other beavers.

CANDIDATES & BIOS



For President and at Large Director: Michael DeVita

Originally from Bergen County, NJ, I have lived on Iroquois Road in Walker Lake since April 2000. I first became a WLLA board member in January 2018 and

served until July of 2019. I returned to the board in September 2020 and have been there since. As many of you know I have been serving continually as the Road Committee Chair since 2018. I have discussed the road status with many of you on Facebook or email about the roads, acknowledging the frustration many of us feel at times. I feel this is the most major issue facing the community and we need to continue to look for solutions to better maintain and improve our roads. It is about trying to find affordable solutions that when done are accomplished correctly.

Seasonal Notes

Road Maintenance

Road work began in May after the Board awarded a contract to fix all the potholes and conduct other pavement repairs at a cost of \$31,060. A contract for the gravel roads was issued and the road materials were purchased by WLLA for \$55,000. The road repairs are in progress.

Remember, you are responsible for cleaning the ditches along your property. Now is the perfect time to rake and/or dig out your ditch lines to ensure the water flows properly and does not erode the roadways.

Bear Prevention

The bears are back and already wreaking havoc on our trash throughout the community. If they get into your garbage, please pick up all scattered trash in the surrounding areas. An effective deterrent is to soak a rag with ammonia or other strong disinfectants and put it on the top of the trash. This is more effective than dumping it into the can to dissipate.

Security

St. Moritz Security Services is now patrolling. Please remember badges will be checked at all beach and boat launch locations around the lake. This is to ensure that only those who pay their dues are enjoying the amenities of the community. Please contact the office to coordinate badge pickup.

Dog Walking

Please remember to pick up after your dog when out for a walk. This will help ensure dog waste does not get washed into the lake and contribute to higher bacteria levels. Please also refrain from dumping dog feces into the cans of others. If elected president, I'll take time listen and discuss with you your ideas to improve the community in a variety of areas, and then work to build a consensus in the areas that need improvement. The goal would be to continue the path to ensure Walker Lake becomes the wonderful vibrant community it is meant to be. With the hope by doing so, it will protect and increase our home values.

While the Board has made great strides in the past five plus years, there is still much ahead to do for the future of the Walker Lake community. While I acknowledge we do need rules and regulations to help govern the community, I feel those rules and regs must not be burdensome or intrusive on our personal lives and the ability to enjoy our beautiful community.

I retired from the New Jersey Department of Transportation in 2014 after 38 years. During my career I served in a variety of leadership positions including Area Supervisor and Management Operations Analyst. For five years, I oversaw the Region North Regional Emergency Operations Center which covers the entire seven northern counties of NJ, at times overseeing over 1,000 pieces of snow equipment and personnel. I also oversaw NJDOT Region North support operations to the World Trade Center rescue and recovery during 9/11. After retiring, I worked as a consultant back at NJDOT for 5 years.

I have been volunteering in organizations since I was 17 years old, and in many of the organizations served as an officer including president. I also serve as ordained deacon at the Evangelical Presbyterian Church in Milford. In addition to being the WLLA Road Committee chairperson and I serve on the Membership (nominations) Committee. I have previously served as the Communications Committee chair and as a member of the Rules and Regulations Committee. I've been married for just over 40 years to my wife Nancy, and we have three sons and two grandchildren.

Fireworks

No Fireworks are to be used on any Walker Lake Shores Landowners Association owned property including but not limited to any of the beaches, lake, boat launch, dam area, tennis court, clubhouse parking area, and other WLLA owned land. If you choose to use fireworks on your own property you MUST follow Pennsylvania Law Act 43 of 2017 which is stated in part below:

- Fireworks cannot be discharged within 150 feet of an occupied structure.
- Fireworks cannot be ignited or discharged on a public or private property without express permission of the property owner.
- Fireworks cannot be discharged from or within a motor vehicle or building.
- Fireworks cannot be discharged toward a motor vehicle or building.
- Fireworks cannot be discharged while the person is under the influence of alcohol, a controlled substance, or another drug.

Tick Prevention & Testing

As you likely know, tick activity levels are high in our area and can carry harmful diseases. Wear light clothes, tuck pants into socks and treat skin and clothes with 20% DEET or essential oils. Put your clothes in the dyer on high immediately after coming indoors. Avoid grass areas when possible and perform tick checks on armpits, hair, groin, etc. within 2 hours of being inside.

My professional background is in Environmental Compliance, and I hold a BS in Civil Engineering. Prior to my retirement and relocation here, I was Director of Environmental Affairs for Sony Pictures Entertainment's worldwide headquarters in Culver City, CA. I also serve on the Twin and Walker Lake Creeks Watershed Conservancy (TWCWC) Board.
